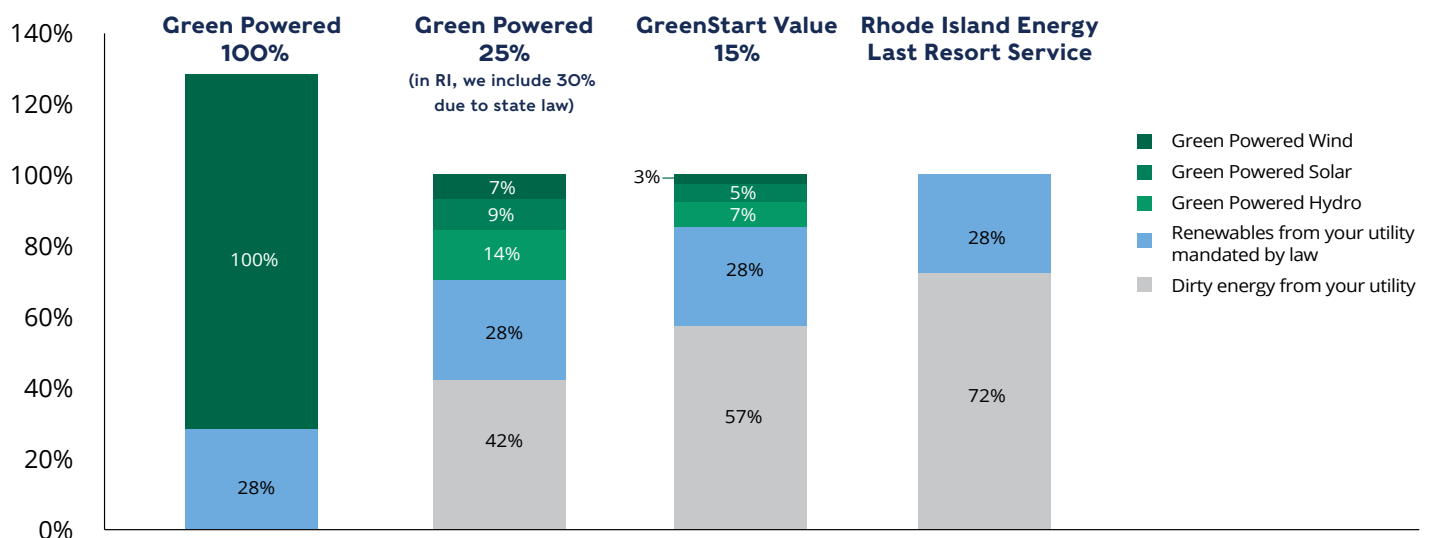

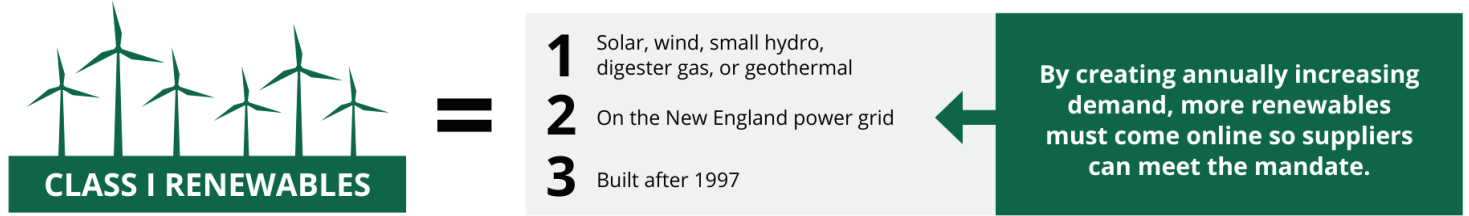
## Renewable Energy Certificates *For power produced 4/1/24 - 6/30/24*



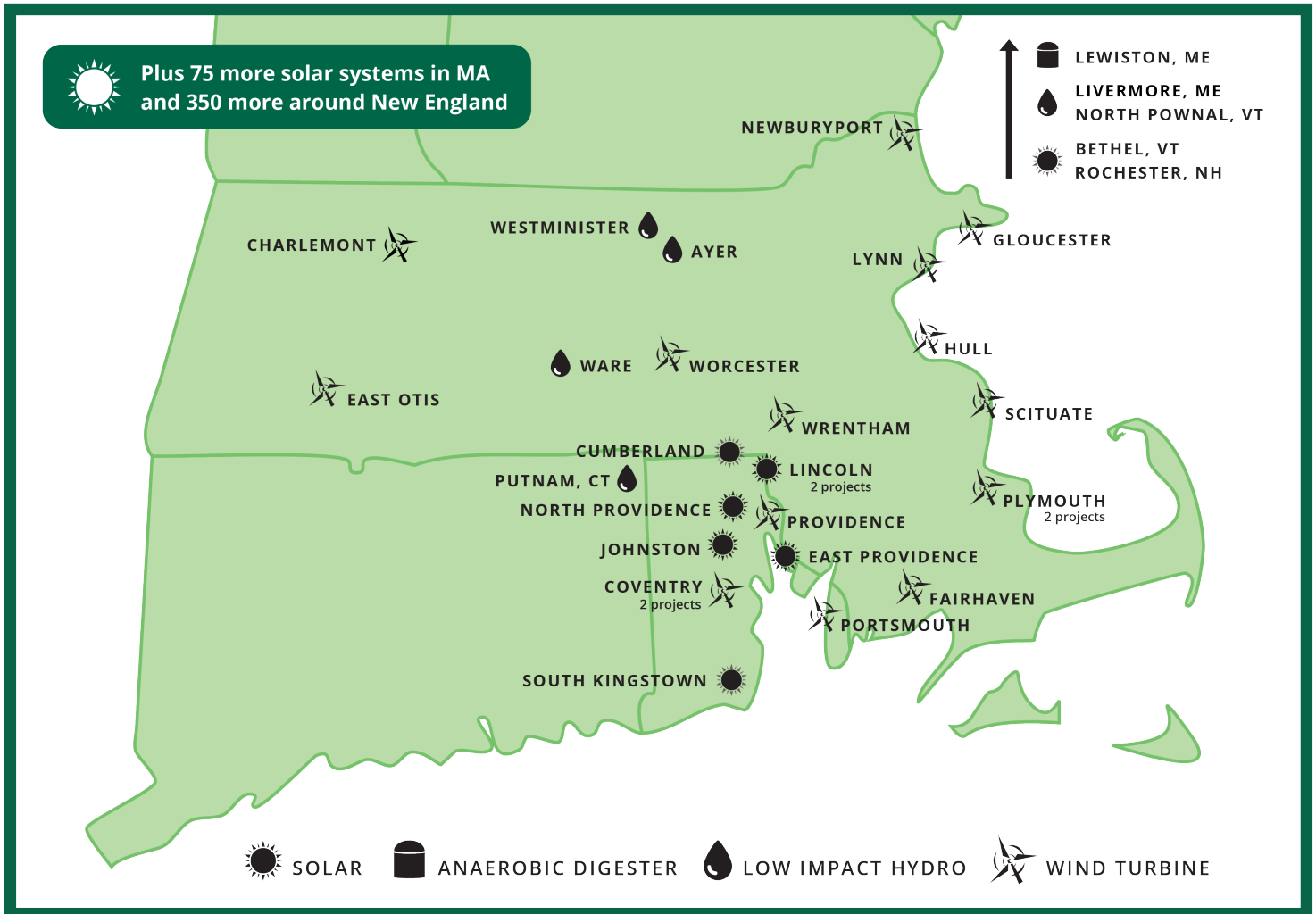

**What are Renewable Energy Certificates (RECs)?** For every megawatt hour (MWh) of electricity that a renewable energy generator puts on the grid, a REC is created to document it. RECs represent and can be sold separately from electrons, thereby creating an extra stream of funding for renewable energy projects. We purchase & retire RECs for the energy you consume so you can claim that your electricity came from renewable energy sources. RECs are retired 6 months (or more) after they are generated, which is why this disclosure label covers a period in the past.

In Massachusetts and Rhode Island, laws require that utilities and suppliers buy an increasing amount of local "Class I" or "new" renewable energy on our behalf. This creates an incentive to build renewable generators in New England, and by voluntarily choosing to buy Class I yourself, you're driving up demand.

## Notes

1. Electricity customers in New England are served by an integrated power grid, not particular generating units. This information is based on the most recently available information provided to suppliers via the NEPOOL GIS System. Rhode Island Energy procures its electricity supply for Last Resort Supply Service, on behalf of its customers from system power contracts, not from specific generating units.

3. Green Powered 30% is an extra 2.2 cents per kWh for all customer types. GreenStart Value is an extra 1.25 cents per kWh for all customer types. Green Powered 100% is an extra 3.8 cents per kWh for all customer types. Check your electric bill for your customer type.
